

# GP X US POKER OPEN 2023 PROMOTION RULES

### NO PURCHASE NECESSARY TO ENTER OR WIN

- 1. These rules (**Promotion Rules**) form a legal agreement between you and **VGW Group** (also referred to as **us**, **we** and **our**). Capitalized terms used but not defined in these Promotion Rules have the meanings given to them in our <u>Terms and Conditions</u>.
- 2. **Promotion Period:** The Promotion is open between 12:01 am on August 21, 2023 and 11:59 pm on September 3, 2023 (**Promotion Period**). All time and date references in these Promotion Rules are according to Eastern Time. Unless stated otherwise, all references to prices, purchases or monetary value in these Promotion Rules are in United States Dollars.
- 3. Eligibility: You are only eligible for this Promotion if you have met all of the following criteria:
  - (i) You satisfy all relevant requirements set out in our <u>Terms and Conditions</u>, including but not limited to the age and residency requirements in clause 3.1. of our <u>Terms and Conditions</u>;
  - (ii) You are not an employee or contractor of VGW Group, its affiliates, subsidiaries, and agencies, or member of their immediate family or persons living in the same household; and
  - (iii) You have an active Global Poker Customer Account.

#### 4. Promotion Details:

(i) The 'GP x US Poker Open 2023' promotion (**Promotion**) consists of the following challenges, tournaments, rewards and promotions (**Events**) that will run throughout the Promotion Period as set out in the table below:

(iii) Where physical prizes are made available as part of this Promotion, all such physical prizes (including GP merchandise) are subject to availability, and we reserve the right to substitute any physical prize with another of equivalent value without giving notice.

## 5. Leaderboard Challenge

- (i) Players that participate in Promotion GC Tournaments and Promotion SC Tournaments stand to be allocated points on the GC leaderboard and SC leaderboard respectively.
- (ii) To qualify to receive points, a player must finish a Promotion GC Tournament or Promotion SC Tournament in a winning position as set out in the 'Tournament Summary' for that tournament in the 'Tournament' lobby. The number of points the player stands to receive is calculated using this formula and will be rounded up to two decimal places:

```
Points = 10 * ((Field Size^(1/3)) / (Position^(1/3))) * (1 + log10(Buy-in+0.25))
(Note: The "Buy-in" amount in the above formula excludes the tournament entry fee.)
```

Example 1: Player A finishes in a winning position of 8th in a Promotion GC Tournament where the buy-in (less tournament entry fee) is GC50,000 and the field size is 300 players. The total points awarded to Player A

- $= 10 * ((300^{(1/3)}) / (8^{(1/3)})) * (1 + log10(50000+0.25))$
- = 190.7539878
- = 190.75 (rounded)

Example 2: Player B finishes in a winning position of 4th in a Promotion SC Tournament where the buy-in (less tournament entry fee) is SC50 and the field size is 500 players. The total points awarded to Player B

- $= 10 * ((500^{(1/3)}) / (4^{(1/3)})) * (1 + log10(50+0.25))$
- = 135.0568033
- = 135.06 (rounded)
- (iii) The leaderboards list players in order of descending points value, so that players with more points are higher up a leaderboard.
- (iv) Points accumulated from:
  - a. Promotion GC Tournaments will only count towards the GC leaderboard; and
  - b. Promotion SC Tournaments will only count towards the SC leaderboard.
- (v) The total points that a player accumulates during the Promotion through participating in Promotion GC Tournaments and Promotion SC Tournaments will be reflected on the GC leaderboard and SC leaderboard respectively.
- (vi) Within 72 hours of the end of the Promotion Period, the final scores for the leaderboards will be calculated and the top 10 players (based on points, not position) on the GC leaderboard and the SC leaderboard stand to receive prizes in accordance with the table below. If two or more players are eligible to win a prize and are tied for points, we will decide in our sole discretion to either split the prizes, or organize a playoff to determine what prize each player will get.

## 6. Naming of Golden Scrimmage Tournament:

- (i) The winner of the GC Leaderboard Challenge stands to have a 'Golden Scrimmage' tournament of our choosing renamed after the winner's poker alias.
- (ii) Notwithstanding (i) above, we reserve the right to reject or amend the proposed name for the tournament if, in our sole discretion, we deem the winner's poker alias offensive, racist, derogatory, obscene or otherwise inappropriate.

## 7. 'Las Vegas Prize':

- (i) Subject to (v) below, the winner of the SC Leaderboard Challenge stands to win the following prize (Las Vegas Prize) which is comprised of:
  - a. a \$5,000 cash prize (**Cash Prize**) which the winner can use to pay for travel and accommodation expenses associated with their travel to Las Vegas to attend a prizegiving ceremony at the PokerGo studios in Las Vegas (**Ceremony**); and
  - b. the opportunity to be presented with a golden trophy, a framed USPO felt and a check for \$5,000 at the Ceremony (Ceremony Prize).
- (ii) The winner agrees to take all reasonable steps to provide us with at least 2 weeks' prior notice of their travel dates and cooperate with us to facilitate the organization of the Ceremony at a mutually-suitable date and time.
- (iii) The winner is solely responsible for:
  - a. arranging their travel to and from Las Vegas and the Ceremony, including arranging any passports or visas that may be required;
  - b. ensuring they are fit to travel and have received appropriate immunizations and health checks; and
  - c. obtaining travel insurance. TRAVEL INSURANCE IS HIGHLY RECOMMENDED TO PROTECT AGAINST THE ADDITIONAL COSTS THAT MAY BE INCURRED IN THE EVENT OF UNFORESEEN CIRCUMSTANCES.
- (iv) All income taxes resulting from acceptance of the Las Vegas Prize are the responsibility of the winner.
- (v) To be eligible to receive the Las Vegas Prize, the winner must satisfy all verification requirements as set out in our <u>Terms and Conditions</u>.
- 8. Intellectual Property Rights: By participating in this Promotion, you:

- (i) understand that we may photograph, film and/or record you and your property (both personal and real);
- (ii) grant us and third parties acting on our behalf an irrevocable, perpetual, exclusive, world-wide, royalty free, sub-licensable, transferable license to:
  - a. use, reproduce, copy, publish, modify, alter and distribute all photographs and recordings of, or relating to, you and your property (both personal and real) (**Work**) in any manner in which we see fit, including by way of promotion, advertising and public relations; and
  - b. use your name, image, physical likeness, voice and any and all attributes of your personality and/or performance (appearance) as shown in the Work for promotional, marketing and advertising purposes, in any medium.
- 9. **'Hometown Heroes' Promotion:** Promotion GC Tournament winners and Promotion SC Tournament winners are eligible to enter the 'Hometown Heroes' promotion as governed by the <u>Hometown Heroes Promotion Rules</u>.
- 10. Winner notification: Prizes for certain Events such as Gold Coins or Sweeps Coins will be awarded to the winners instantly. Where prizes for the Promotion are not awarded instantly, prize winners will be notified electronically by their last known email or phone number. In such cases, if a prize winner doesn't sign and return any required release form and/or respond to accept their prize within 15 days of notification, they may be disqualified and will not receive their prize. We will then award the applicable prize to an alternate winner at our sole discretion.
- 11. **General terms and conditions**: By entering this Promotion, you agree to be bound by these Promotion Rules, which include and are inseparably linked to Global Poker's <u>Terms and Conditions</u>, <u>Privacy Policy</u>, <u>Responsible Social Gaming Policy</u>, <u>Customer Acceptance Policy</u> and <u>Sweeps Rules</u> (collectively, the **Official Rules**), and by the decisions of VGW Group, which are final on all matters relating to the Promotion. VGW Group reserves the right, in its sole discretion, to amend these Promotion Rules or to otherwise cancel, suspend or modify this Promotion in any manner it deems appropriate at any time and without prior notice to you. You will have no legal recourse against the Promotion Parties (defined below) or their respective employees, for any such change, suspension or termination. We reserve the right, in our sole discretion, to disqualify any player which we believe:
  - (i) has tampered or attempted to tamper with the entry process or the operation of the Promotion; or
  - (ii) otherwise violated these Promotion Rules or our Official Rules; or
  - (iii) acted in an unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass any other person.

- (iii) AGREE THAT, TO THE MAXIMUM EXTENT PERMITTED BY LAW, WE, OUR DIRECTORS, OFFICERS, EMPLOYEES, SHAREHOLDERS, AGENTS, AFFILIATES AND RELATED ENTITIES (COLLECTIVELY THE **PROMOTION PARTIES**):
  - a. WILL NOT BE RESPONSIBLE TO YOU IN CONTRACT, TORT, NEGLIGENCE OR OTHERWISE FOR, AND ARE RELEASED FROM, ANY AND ALL COSTS, INJURIES, LOSSES OR DAMAGES OF ANY KIND (WHETHER DIRECT, INDIRECT, SPECIAL, CONSEQUENTIAL, EXEMPLARY, PUNITIVE OR OTHER), INCLUDING, WITHOUT LIMITATION, DEATH AND BODILY INJURY/ILLNESS, DEEMED OR ALLEGED TO HAVE ARISEN IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY, FROM OR IN CONNECTION WITH YOUR PARTICIPATION IN THE PROMOTION, YOUR TRAVEL TO/FROM AND ATTENDING THE CEREMONY, ANY ADDITIONAL PROMOTION OR ANY RELATED ACTIVITY; AND
  - b. HAVE NOT MADE ANY WARRANTY, REPRESENTATION OR GUARANTEE EXPRESS OR IMPLIED, IN FACT OR LAW, WITH RESPECT TO THE LAS VEGAS PRIZE OR ANY OTHER PRIZE, INCLUDING, WITHOUT LIMITATION, TO SUCH PRIZES' QUALITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT; AND
